



INTERNAL RULES

CAMPING LE VAUGRAIS***

" The luxury of simplicity in the heart of nature"

2026 Season: From April 4th to September 20th

1. CONDITIONS OF ADMISSION AND STAY

- **Authorization:** To enter, settle, or stay on the campsite, you must be authorized by the manager.
- **Acceptance:** Staying at the campsite implies full acceptance of these rules and a commitment to comply with them.
- **Target Audience:** Our establishment is for individual or family tourists only. We do not host professional groups (work crews) or large youth groups (summer camps).
- **Video Surveillance:** For the safety of people and property, the campsite is under video surveillance across the entire grounds.

2. RECEPTION AND FORMALITIES

- **Office Hours:** The reception is open from **8:00 AM to 12:00 PM** and from **2:00 PM to 7:00 PM**.
- **Police Formalities:** Identification must be presented. Foreign guests must sign an individual police form upon arrival.
- **Minors:** Unaccompanied minors are not admitted.
- **Mediation:** For any unresolved dispute, the client may contact the consumer mediator CM2C (Paris, France).

3. QUIET HOURS AND CONDUCT

- **Quiet Hours:** Total silence is required between **10:00 PM and 8:00 AM**. Please be considerate of others.
- **Smoking & Vaping:** It is strictly **forbidden to smoke or vape** inside all rental accommodations and in all public indoor areas (reception, restrooms, etc.).
- **Air Conditioning:** The use of mobile A/C units on pitches must not be set to "maximum" mode to avoid disturbing neighbors, especially at night. Respect for others is mandatory.

- **Pets:** Must be kept on a leash, never left alone (even if locked in), and owners are civilly liable for them.

4. SWIMMING POOL (STRICT HYGIENE & SAFETY)

- **Access:** Strictly reserved for campsite guests (visitors are forbidden).
- **Hygiene:** Using the **footbath (pediluve) is mandatory**. Shoes are strictly forbidden inside the pool enclosure.
- **Dress Code:** Only swim briefs or trunks (lycra) are allowed. Swim shorts and bermudas are strictly forbidden.

5. BARBECUES AND FIRE SAFETY

- **On Pitches:** Barbecues are tolerated on your pitch.
- **July/August Restrictions:** In case of a prefectural decree or drought, charcoal barbecues may be banned. In this case, only gas or low-power electric devices (planchas, grills) are allowed.
- **Power:** High-power electric barbecues are forbidden to prevent power outages.
- **Open Fires:** Ground fires are strictly prohibited.

6. TRAFFIC AND ELECTRIC VEHICLES

- **Speed Limit:** Speed is strictly limited to **5 km/h** (3 mph) throughout the campsite.
- **EV Charging:** It is **strictly forbidden** to charge an electric or hybrid vehicle using the campsite's outlets (accommodation or pitches). A slow-charging station (E-TOTEM) is available 1 km away at Carrefour Contact.

7. RIGHT TO IMAGE (PHOTOGRAPHY)

- **Authorization:** Unless notified in writing to the management upon arrival, you authorize the campsite to use your image (photos or videos taken on-site) for promotional materials (website, brochures, social media).
- **Minors:** Authorization for minors is deemed granted by their legal representatives staying with them.

8. VISITORS (STRICTLY FORBIDDEN)

- Access to the campsite is reserved for registered guests. **Visitors are not allowed** to enter the premises, even temporarily.

9. OCCUPANCY AND LIABILITY

- **Capacity:** The contract will be cancelled if the number of people on arrival exceeds the capacity stated in the booking.
- **Environment:** Do not pour wastewater on the ground. Clotheslines must be floor-standing (hanging lines between trees are forbidden).
- **Insurance:** Guests must have personal civil liability insurance. The campsite declines all liability for theft or damage caused by natural elements (storms, hail).

10. BREACH OF RULES

- Any serious or repeated breach of these rules may lead to immediate eviction and

termination of the stay contract.
